Jennifer is the Founder and President of Media Street Productions Inc., a twenty-five-year old, awardwinning media company in Windsor, Ontario.

Jennifer has strengthened Rotary's reach and impact through her service in many roles including as Trustee of the Rotary Foundation, RI Vice President, and co-chair of the End Polio Now: Make History Today campaign. As a professional communicator, Jennifer also used her vocational strength to chair the advisory group that crafted Rotary's rebranding effort.

Working alongside government officials, celebrities and global leaders, she utilizes her voice to raise awareness and hundreds of millions of dollars to eradicate disease, support peace and provide clean water and sanitation in developing areas of the world. Johrita Solari

Johrita Solari is board chair and chief visionary officer of Solari Enterprises Inc., a property management company with 300 team members specializing in affordable rental housing. The company, which she co-founded with her husband, Bruce, was inspired by Rotary's guiding ethical principles. "The Four-Way Test hangs in our lobby, and every team member sees it as they come into work," Solari says.

Solari joined Rotary in 1993. As governor of District 5320, she organized the district's first million-dollar dinner fundraiser for The Rotary Foundation and helped it become the second known district consisting of 100% Paul Harris Fellow clubs. She has served on the committee for the Foundation's Peace Major Gifts Initiative.

The Solaris are members of the same Rotary club and support the Foundation as Paul Harris Fellows, Major Donors, and members of the Arch Klumph Society. During Solari's second year as director, her daughter Gianna will serve as a district governor, making it the first time in Rotary history that a mother and daughter have served in these two leadership roles simultaneously.



Stephanie A. Urchick Director 2019-21 Rotary Club of McMurray

Stephanie A. Urchick is partner and chief operating officer of Doctors at Work LLC, a consulting and training company. She holds a doctorate in leadership studies from Indiana University of Pennsylvania. She is active on numerous community boards and committees and has been honored by organizations including Zonta International and the Sons of the American Revolution.

A Rotarian since 1991, Urchick first joined the club of Past RI President Chuck Keller, who served as her mentor. Her service to Rotary has taken her to Vietnam to help build an elementary school and to the Dominican Republic to install water filters. A student of several Slavic languages, she has mentored new Rotarians in Ukraine and coordinated a Rotary Foundation grant project in Poland.

Urchick has served Rotary in many roles, including as a Foundation trustee and as chair of the RI Strategic Planning Committee and the Foundation's Centennial Celebration Committee. She is a Major Donor and a member of the Bequest Society of The Rotary Foundation.



Peter R. Kyle

Director 2020-22 Rotary Club of Capitol Hill (Washington, D.C.) District of Columbia, USA

Peter R. Kyle was born and raised in New Zealand. After graduating with honors degrees in law and economics from Victoria University of Wellington, he clerked for the chief justice of New Zealand before pursuing postgraduate studies in law at the University of Virginia on a Rotary Foundation Ambassadorial Scholarship.

In 1992, after a career in private legal practice in New Zealand and a senior role with the Asian Development Bank in the Philippines, Kyle returned to the United States to work as a senior international attorney with the World Bank, based in Washington, D.C. Two weeks after accepting the position, his first assignment took him to Moscow to advise on the transition of the former Soviet Union from a socialist system to one based on market principles. He retired in 2009 but continues to serve as a consultant to the World Bank.

A Rotarian since 1976, Kyle has served Rotary in many capacities, including as an RI training leader, Council on Legislation representative, RI president's representative, and dean of the Rotary Representative Network. In addition to serving on the board of the Water and Sanitation Rotarian Action Group, he has chaired Rotary's Alumni Relations and Rotary Peace Centers committees. Besides Rotary, his other great love has been Outward Bound International, which he has served as founding chairman. In 2010, Kyle received the Rotary Foundation Global Alumni Service to Humanity Award, which he considers one of his proudest moments in Rotary. He has also received the Service Above Self Award and The Rotary Foundation Citation for Meritorious Service. He is a Major Donor, Paul Harris Society member, and — like all his family members — a Paul Harris Fellow.



Jerry Hall

Jerry is a retired professional engineer (civil) and worked as the Executive Director of the Regional Transportation Commission with responsibility for design and construction of arterial highways and operation of a public transit system. After his retirement as Executive Director, the Commission renamed a 6.7 acre administrative and operations complex the "Jerry L. Hall Regional Transportation Center." He has also worked as a consultant on civil engineering projects and strategic planning for clients in the public and private sectors.

Jerry joined Rotary in 1977 and he and wife Tasha participated in a Polio National Immunization Day in Ghana, West Africa, and hands-on projects in Romania, Uganda, Mexico and led a Vocational Training Team to Uganda in May, 2014, to assist in the startup of the new Uganda Nursing School, Bwindi.

Jerry and Tasha have hosted 13 exchange students including a second-generation student, the son of a student hosted 22 years earlier. Jerry and Tasha are Rotary Foundation major donors and members of the Bequest Society. Jerry is the recipient of the Rotary International Foundation Distinguished Service Award, the Citation for Meritorious Service and the Rotary International Service Above Self Award.

Jerry has been active in his community serving in leadership roles including past chair and member of the Reno Tahoe Airport Authority, member and vice-chair of the Reno Sparks Convention and Visitors Authority and the Washoe County District Board of Health. He is a recipient of the University of Nevada President's Medal for service to the community and higher education.

Rotary's general secretary and executive team oversee a staff of more than 800, who serve Rotary members from our world headquarters in Evanston, Illinois, USA, and seven international offices. The

general secretary is a member of the Rotary International Board of Directors and The Rotary Foundation Board of Trustees.

John Hewko has served as Rotary International's general secretary and chief executive officer since 2011. A charter member of the Rotary Club of Kyiv, Ukraine, Hewko lives out Rotary's mission, whether inside or outside the office. He's immunized children against polio in India, represented Rotary at the World Economic Forum, and bicycled 104 miles (167 km) with Rotary members in Arizona, USA, to help raise over \$50 million for polio eradication. "It's an honor to go the extra mile in serving this great organization. I see Rotary as the original social network formed to exchange ideas and resources so we can transform lives. We're a bold NGO that believed it could end a disease, and we've stuck to the cause for over three decades. That thought inspires me every morning.".

John Hewko is the general secretary and chief executive officer of Rotary International and The Rotary Foundation. From 2004 to 2009, Hewko was vice president for operations and compact development for the Millennium Challenge Corporation, a U.S. government agency established in 2004 to deliver foreign assistance to the world's poorest countries.
